

WP6 Objectives and Workflow

- CS approach: testing and validating selected evaluation methods
- Process: Recurring specific local (national) stakeholder/expert
 consultations of case study results to validate practical applicability.
- Result: Showcase of public good case studies
 - NOT: to provide evaluation result as such

WP6 Task 6.1: Selection of study areas

Timeframe: 01/09/2013-31/01/2014

Task Leader: P7 – SZIE

- appropriate geographic scales & concrete study areas for each public good case study will be selected in collaboration with national and regional stakeholders.
- guidelines for the selection of the study areas, key factors for the selection:
 - data availability,
 - policy relevance in terms of the implemented measures,
 - stakeholder relevance,
 - structural characteristics of farming and forestry
 - suitability for the public good in concern
- The selected case study areas will be presented & discussed with National Stakeholder Reference Groups at workshop in November 2013 and summarised in a report in month 13 (Jan 2014) (D6.1).

WP6 Task 6.2: Development of case study database

Timeframe: 31/01/2014-01/08/2014 (Month 13-20) Task Leader: P7 – SZIE

- based on guidelines from WP3 WP5 databases for the case studies will be developed.
- database development will take into account *different spatial disaggregation levels* from NUTS 2 providing different spatial options for the application of evaluation methods allowing micro & macro tests in each partner country.
- □ issues to be addressed in the *development of the data infrastructure*
 - data formats, data rights,
 - development of procedures for dealing with different demarcation of geographical units between different data sets, and
 - protocols for aggregating and anonymization of individual farm and firm



data.



WP6 Task 6.3: Testing of methods

- selected methods will tested
 - for their consistency and cost-effectiveness in evaluating net effects of RDPs at micro and macro levels
 - in two rounds of public good case studies (recurring iterative review and improvement during the testing phase)
 - in the selected areas in the partner countries.
- Based on the guidelines provided by WP7 *data on the cost and the effectiveness* of the application of the different evaluation methods in the partner countries will be collated and fed back to WP7
